POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in special session on May 11, 2000. Present were Power County Commissioners Kent Rudeen, Chairman, Ken Estep and Valerie Hoybjerg. Also present was Power County Clerk Christine Steinlicht.

COMMUNITY RESOURCE COORDINATOR: The Commissioners met with Judy Meline to discuss an interim part-time Community Resource Coordinator position in Power County. The Board advised Mrs. Meline that the temporary, part-time position would include administering the Power County Parent Project, attending the monthly Community Advisory meeting and providing women's advocate services. Moved by Commissioner Hoybjerg, seconded by Commissioner Estep, to appoint Judy Meline as interim part-time Community Resource Coordinator for Power County at the rate of \$10.00 per hour. Carried.

PARENT PROJECT: Parent Project facilitators Connie Shepherd, Sharee Sprague, Jerrie Boyce, Kay Stilwell, Jose Favela and Michelle Favela met with the Commissioners and the new interim Community Resource Coordinator Judy Meline. Commissioner Hoybjerg suggested that the Parent Project Board and Mrs. Meline go through the by-laws and advise the Commissioners of any changes which need to be made.

SOUTHERN IDAHO SOLID WASTE: Terry Schultz of Southern Idaho Solid Waste appeared before the Commissioners to discuss the County's solid waste transport contract with Waste Connections. Mr. Schultz will submit a bid to provide Power County with solid waste transport services.

JUVENILE JUSTICE: The Commissioners reviewed the notice received from the Juvenile Justice Commission encouraging County participation in a Juvenile Justice grant writing class which is being held in Pocatello on May 17th. Commissioner Hoybjerg will discuss the class with Juvenile Probation Officer Russ Wheatley.

POWER COUNTY PROBATION OFFICE: County Attorney Rob Naftz has requested that the Commissioners install a door to his temporary Probation Department Office. Commissioner Estep will ask Extension Agent Stan Gortsema if they might have the original door in storage. In the event the original door cannot be located, Commissioner Estep will talk to Gary Thompson about getting a replacement door installed.

CLINIC RENT: Commissioner Hoybjerg suggested that County Attorney Naftz write a letter in an effort to collect the past due rental amount owing for the Doctors Clinic.

BUILDING ADMINISTRATOR: Moved by Commissioner Estep, seconded by

Commissioner Hoybjerg, to allow Richard Wiles to accrue up to ten hours overtime each week for the next six weeks to be paid at time and a half from 01-18-406-00, which ten hours will include Planning & Zoning meetings. Carried. The Commissioners then reviewed the Agreement of Cooperative Action Regarding Inspection Of Building Activities Within the City Limits of Rockland, Idaho, which was prepared by County Attorney Rob Naftz. Moved by Commissioner Estep, seconded by Commissioner Rudeen, to approve the renewal agreement as presented. Carried.

PLANNING & ZONING: The Commissioners then discussed building permits for agriculture buildings. State code allows agriculture buildings to be exempt from the requirements of the Uniform Buildings Code fee and rule schedules. Commissioner Estep suggested that Power County amend it's building code resolution to allow for an exemption for agriculture building pursuant to I.C. #39-4105 and #63-112, which will require a public hearing. Moved by Commissioner Estep, seconded by Commissioner Hoybjerg to schedule a public hearing on the proposed resolution for June 12, 2000, at 12:00 o'clock noon. Commissioner Estep will advise County Attorney Naftz that a proposed resolution will need to be prepared to publish along with the notice of public hearing.

PRIMARY ELECTION TESTING: At the suggestion of the Idaho Secretary of State, County Clerk Steinlicht conducted a test of the tabulating equipment to be used at the Primary Election on Tuesday, May $23^{\rm rd}$, which testing was performed with the Board of Commissioners present. The local political party officials declined participation in the testing.

EXECUTIVE SESSION: Moved by Commissioner Estep, seconded by Commissioner Rudeen, to move into executive session for the purpose of taking up legal issues. Carried.

CIRCUIT BREAKER: The Commissioners reviewed the circuit breaker applications submitted by the Power County Assessor. Moved by Commissioner Hoybjerg, seconded by Commissioner Estep to approve the applications as submitted. Carried.
