

POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in special session on Thursday, May 25th, 2006. Present were Commissioners Ken Estep, Chairman, and Ray Zimmerman. Also present was Power County Clerk Christine Steinlicht.

2006 PRIMARY ELECTION – BOARD OF CANVASSERS (I.C. #34-1205): The Board of Power County Commissioners met as the Power County Board of Canvassers pursuant to Idaho Code #34-1205. Power County Clerk Christine Steinlicht presented the Board with a copy of the 2006 Primary Election Abstract for their review. Following discussion, it was moved by Commissioner Zimmerman, seconded by Commissioner Estep, to approve the 2006 Primary Election Abstract as presented. Carried. Clerk Steinlicht will submit the original abstract to the Idaho Secretary of State. (SEE ATTACHED).

EXECUTIVE SESSION (I.C. #67-2345): Moved by Commissioner Zimmerman, seconded by Commissioner Estep, to move into executive session pursuant to I.C. #67-2345 for the purpose of taking up indigent medical applications. Carried.

INDIGENT CASE #2006-08-I: Moved by Commissioner Zimmerman, seconded by Commissioner Estep, to deny indigent medical application #2006-08-I, since the applicant has other resources sufficient to pay the medical expenses incurred pursuant to I.C. #31-3502(17). Carried.

PUBLIC DEFENDER CONTRACT – CALL FOR BIDS: Following discussion, it was moved by Commissioner Estep, seconded by Commissioner Zimmerman, to publish a “NOTICE OF CALL FOR BIDS” for Power County Public Defender services for fiscal year 2007 in the May 31st, June 7th and June 14th, 2006, editions of the Power County Press. Carried. This matter was tabled until June 19th, 2006.
