The Board of Power County Commissioners met in special session on Monday, June 19<sup>th</sup>, 2006. Present were Commissioners Ken Estep, Chairman, Vicki Meadows and Ray Zimmerman. Also present was Power County Clerk Christine Steinlicht.

POWER COUNTY SHERIFF – POWER COUNTY JAIL: Power County Sheriff Jim Jeffries appeared before the Commissioners to discuss his fiscal year 2007 budget request for the Power County Sheriff's Office and Jail.

POWER COUNTY SEARCH & RESCUE: Power County Sheriff Jim Jeffries and Power County Search & Rescue member Pete Williams appeared before the Commissioners to discuss their fiscal year 2007 budget request for the Power County Search & Rescue.

POWER COUNTY ASSESSOR/REVLUATION: Power County Assessor Doug Glascock appeared before the Commissioners to discuss his fiscal year 2007 budget request for the Power County Assessor and Revaluation.

POWER COUNTY TREASURER: Power County Treasurer Bobbie Mauch appeared before the Commissioners to discuss her fiscal year 2007 budget request for the Power County Treasurer's Office.

GERALD FEHRINGER YOUTH CENTER: Gerald Fehringer Youth Center Board member Bobbie Mauch appeared before the Commissioners to discuss the Youth Center's fiscal year 2007 budget request.

POWER COUNTY EMPLOYEE MEDICAL INSURANCE BENEFIT PLAN – GEM PLAN: Commissioner Estep reported that Power County's Gem Plan agents at Mutual Insurance anticipate that there will be no increase in Power County's Gem Plan premiums for fiscal year 2007.

POWER COUNTY AIRPORT: Power County Clerk Christine Steinlicht reported that Airport Manager Stan Bearup has requested that the Airport's fiscal year 2007 budget request hearing be rescheduled for Monday, June 26<sup>th</sup>, 2006, at 9:30 a.m. and this matter was tabled until that time.


