POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in regular session on Monday, July 28th, 2008. Present were Commissioners Vicki Meadows, Chairman, Ken Estep and Ron Funk. Also present was Power County Clerk Christine Steinlicht.

ALCOHOL BEVERAGE LICENSES (I.C. #63-903): Commissioner Meadows announced that it was the date and time scheduled for consideration of a number of alcohol beverage licenses. There being no public objection, it was moved by Commissioner Meadows, seconded by Commissioner Funk, to approve the following alcohol beverage licenses:

- 14. NPC International, Inc. d/b/a Pizza Hut for the sale of bottled or canned beer to be consumed on the premises.
- 15. Patricia J. Payne d/b/a O'Grady's Gas & Grocery for the sale of bottled or canned beer not to be consumed on the premises.
- 16. Lonnie and Tina Lowder d/b/a Casey's Restaurant & Lounge for the sale of draught and bottled or canned beer to be consumed on the premises and retail liquor.
- 17. Trent & Vernessa Rupe d/b/a Rupe's Rockland Café for the sale of draught and bottled or canned beer to be consumed on the premises and retail wine.

NORTHWESTERN ENERGY – MOUNTAIN STATES TRANSMISSION LINES: Kevin Everett of Northwestern Energy appeared before the Commissioners to discuss Northwestern Energy's proposal to build and operate a new 500kv transmission line between Southwestern Montana and Southeastern Idaho, a portion of which is expected to run through Power County. Mr. Everett presented a map depicting several alternative routes and encouraged the Commissioners to view Northwestern Energy's internet site www.msti500kv.com.
