

## POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in special session on Wednesday, June 6<sup>th</sup>, 2012. Present were Commissioners Vicki Meadows, Chairman, Ron Funk and Delane Anderson. Also present was Power County Clerk Christine Steinlicht.

COMMISSIONER AGENDA (I.C. #67-2343): Following a review of I.C. #67-2343, and good cause appearing therefore, it was moved by Commissioner Meadows, seconded by Commissioner Anderson, to amend the June 6<sup>th</sup>, 2012, Commissioner Agenda to include the following items:

POWER COUNTY COURTHOUSE – COMPUTER SERVICE ROOM (AIR CONDITIONING): Following discussion with Power County Treasurer Deanna Curry, it was moved by Commissioner Funk, seconded by Commissioner Meadows, to authorize Sierra Heating & Cooling to install a new “first line” cooling unit in the Power County Courthouse computer server room, and to utilize the current air conditioner as a “back up” unit. Carried.

POWER COUNTY WEED DEPARTMENT: Power County Weed Department Supervisor Curtis Munk appeared before the Commissioners to discuss his Fiscal Year 2013 Budget Request.

POWER COUNTY ECONOMIC DEVELOPMENT – GREAT RIFT BUSINESS DEVELOPMENT: Kristen Jensen of Great Rift Business Development appeared before the Commissioners to discuss her Fiscal Year 2013 Budget Request.

POWER COUNTY BUILDING DEPARTMENT/PLANNING & ZONING: The Commissioners reviewed Power County Building Department Supervisor Robert Steinlicht’s Fiscal Year 2013 Budget Request.

POWER COUNTY SENIOR CITIZENS CENTER: Power County Senior Citizens Board Chairman John St. Vincent appeared before the Commissioners to discuss his Fiscal Year 2013 Budget Request.

POWER COUNTY VETERAN SERVICE OFFICER – APPOINTMENT OF OFFICER: Following discussion, it was moved by Commissioner Anderson, seconded by


Commissioner Funk, to appoint Sheldon Kovarsky to fill the vacant position of Power County Veteran Service Officer. Carried.


