POWER COUNTY PLANNING & ZONING — UTILITY TRANSMISSION CORRIDOR (GATEWAY WEST/MOUNTAIN STATES TRANSMISSION ITERTIE PROJECTS) — POWER COUNTY RESOLUTION #2013-01 (TO CLARIFY AND REPLACE RESOLUTION #2012-08 TO RETAIN DOUGLAS J. BALFOUR, CHARTERED): Following a full reading of the same by Commissioner Meadows, and over the public objection of Power County resident Kay Stilwell, it was moved by Commissioner Meadows, seconded by Commissioner Funk, to approve and execute Power County Resolution #2013-01, which is a resolution to clarify and replace Power County Resolution #2012-08, to engage in a contractual relationship with Douglas Balfour in regard to his assistance and representation of Power County in the matters pertaining to the Gateway and MSTI projects.
