#### III. AGENDA

### A. POINTS OF ORDER

 Commissioner Anderson welcomed the Shoshone-Bannock Tribal Officials and presented points for discussion be directed to the entities reaching common ground in Power County, the Airport, FMC and PCDA Property and collaborative efforts for improved relations and economic development for both agencies.

Commissioner Anderson invited members of the Shoshone-Bannock Tribe to express any concerns and collaborative ideas for economic development. Members of the Tribe shared building code enforcement concerns between the entities citing that some parties will not recognize the tribal authority on fee land within the reservation. By consensus, the Commission agreed that the entities should work closely together and assist the other when attempting enforcement of building code and zoning violations.

Ryan Petersen suggested that the entities develop a shared model for building applications for those same type of properties. By having one location for the

applicant to apply may reduce the frustration of applicants in having to address separate governing entity requirements and paying multiple application fees.

The parties expressed shared frustration by the lack of cooperation and collaboration experienced with the City of Pocatello by both entities.

The Commission invited the Shoshone-Bannock Building Administrator to attend a Power County Planning and Zoning meeting in an effort to develop future collaboration and gain insight related to fee land properties within the reservation issues that may need to be incorporated into the Power County Comprehensive Plan.

In conclusion the parties recognized the significance of the meeting and determined that continued communications and meetings would benefit the relations between the agencies.
