

POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in special session on June 15, 1999. Present were Commissioners Kent Rudeen, Chairman, Ken Estep and Valerie Hoybjerg. Also present were County Clerk Christine Steinlicht and County Attorney Rob Naftz.

AIRPORT: Airport Board Chairman Klaren Koopin failed to appear to discuss the Airport Board's Budget request for FY2000. Commissioner Rudeen will contact the Airport Board to see if Wendell Anderson will sign a rental agreement for a monthly fee, plus utilities, on the airport house.

POWER COUNTY CORONER: Bud Kelly, Power County Coroner, appeared before the Commissioners to discuss his FY2000 budget request.

JUVENILE JUSTICE/PROBATION OFFICE: Russ Wheatley, Power County Probation Office Supervisor appeared before the Commissioners to discuss his budget request for FY2000.

POWER COUNTY ASSESSOR: Douglas Glascock, Power County Assessor, appeared before the Commissioners to discuss his FY2000 budget request.

POWER COUNTY TREASURER: Bobbie Mauch, Power County Treasurer, appeared before the Commissioners to discuss her FY2000 budget request.

COURTHOUSE IMPROVEMENTS: Commissioner Rudeen obtained a bid from Yellowstone Glass to replace the windows in the Clerk's office with tinted windows, which is approximately \$400.00 per window.

POWER COUNTY PROSECUTING ATTORNEY: Paul Laggis, Power County Prosecuting Attorney appeared before the Commissioners to discuss his FY2000 budget request.

CONFLICT PUBLIC DEFENDER: County attorney Rob Naftz and Prosecutor Paul Laggis discussed with the Commissioners the appointment of a conflict public defender. Moved by Commissioner Hoybjerg, seconded by Commissioner Estep to appoint Brett P. Allison as conflict public defender until July 1, 2000, at a rate of \$600.00 per month. Carried. Rob Naftz will prepare the contract for the Commissioners' and Mr. Allison's review and approval.

PUBLIC DEFENDER/COUNTY CIVIL ATTORNEY: Power County Public Defender and County Civil Attorney Rob Naftz appeared before the Commissioners to discuss his FY2000 budget requests.

BUILDING ADMINISTRATOR/PLANNING & ZONING: Richard B. Wiles, Power County Building and Planning & Zoning Administrator, appeared

before the Commissioners to discuss his FY2000 requests.


