

POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in special session on August 11, 2000. Present were Commissioners Kent Rudeen, Chairman, Ken Estep and Valerie Hoybjerg. Also present was Power County Clerk Christine Steinlicht.

BUDGET: The Commissioners reviewed the proposed FY 2001 budget and approved the same for publication. Public Hearing will be held on August 28th, 2000, at 12:00 o'clock noon.

DISASTER PROCLAMATION (STATE OF EMERGENCY): The Commissioners reviewed and discussed the Disaster Proclamations which they issued on July 26th and August 2nd, 2000, the nature of which is the occurrence and imminent threat of injury and loss of property arising from extreme drought conditions, high temperatures and electrical storms which have started numerous wildfires within Power County. Disaster Services Director Mark Love appeared before the Commissioners with an itemized sheet of the time and expenses incurred during the recent wildfires in Power County. Moved by Commissioner Hoybjerg, seconded by Commissioner Estep, to pay Mark Love 52 hours at time and a half for extra work required during the state of disaster emergency, to be paid from current expense general. Carried. Moved by Commissioner Estep, seconded by Commissioner Rudeen to reimburse the American Falls Rural Fire District \$1,000 for their efforts in assisting during the Arbon Valley wildfire, to be paid from PILT Disaster Relief. Carried.

CLERK'S PRINTER: County Clerk Christine Steinlicht presented a quote for the purchase of a new laser printer in the Clerk's Office. The request to purchase a new printer was approved by the Commissioners.

RESOLUTION #2000-05 (DISASTER SERVICES LERA DESIGNATION): Moved by Commissioner Rudeen, seconded by Commissioner Estep, to approve Power County Resolution #2000-05 designating Power County Sheriff's Office as the Local Emergency Response Agency for hazardous substance incidents occurring within Power County. Carried.

EXECUTIVE SESSION: Moved by Commissioner Estep, seconded by Commissioner Rudeen, to move into executive session for the purpose of taking up personnel issues. Carried.

RESOLUTION #2000-07 (PLANNING & ZONING SPECIAL USE PERMIT FEES): The Commissioners reviewed proposed Power County Resolution #2000-07, amending the fees for special use permits, and approved the same for publication. Public hearing will be held on August 28th, 2000, at 1:30 o'clock p.m.

RESOLUTION #2000-06 (DEAD ANIMAL DISPOSAL FEE): The Commissioners reviewed proposed Power County Resolution #2000-06 imposing a fee for the disposal of dead animals at the Power County Landfill, and

approved the same for publication. Public hearing will be held on August 28th, 2000, at 1:00 o'clock p.m.
