

POWER COUNTY COMMISSIONER MINUTES

The Board of Power County Commissioners met in special session on Friday, October 12th, 2007. Present were Commissioners Vicki Meadows, Chairman, Ken Estep and Ron Funk. Also present were Power County Clerk Christine Steinlicht and Power County Prosecuting Attorney Paul Laggis.

IDAHO DEPARTMENT OF TRANSPORTATION – I-86, EXIT 40 INTERCHANGE UPGRADE: Ed Bala and Blake Rindlisbacher of the Idaho Department of Transportation appeared before the Commissioners to discuss the I-86, Exit 40 interchange upgrade. Also present were:

Following discussion, Mr. Bala requested that Option #2, as slightly modified, be accepted so that the interchange upgrade can proceed. Following discussion, the Commissioners agreed to take this matter under advisement until October 22nd, 2007, at 4:30 p.m.

POWER COUNTY PLANNING & ZONING BOARD: Following discussion, it was moved by Commissioner Funk, seconded by Commissioner Estep, to appoint Bill Lasley to fill the vacant position on Power County Planning & Zoning Board (January, 2009). Carried.

2007 CERTIFICATE OF COUNTY LEVIES (AMENDED): Clerk Steinlicht reported that City of Pocatello 2007 September Values have been adjusted by the Idaho State Tax Commissioner to remove certain Urban Renewal value; accordingly, the 2007 Certificate of County Levies has been amended to reflect a decrease to the City of Pocatello levies. Following discussion, it was moved by Commissioner Estep, seconded by Commissioner Meadows, to approve the 2007 Certificate of County Levies as amended. Carried. (Attached).

POWER COUNTY TREASURER – WARRANT OF DISTRAINT (AMERICAN AIR): Power County Prosecuting Attorney Paul Laggis appeared before the Commissioners to report that counsel of record in the case of American Air vs. Power County, Power County Case #CV-2007-294, have stipulated to continue the Sheriff's sale on the Warrant of Distraint issued by the Power County Treasurer until the Complaint for Declaratory Judgment and Request for Preliminary Injunction has been heard and a ruling made by

Sixth District Judge Ronald Bush. The Commissioners agreed to table further discussion of this matter until November 26th, 2007.


