## **POWER COUNTY COMMISSIONER MINUTES**

The Board of Power County Commissioners met in special session on Monday, September 29<sup>th</sup>, 2008. Present were Commissioners Vicki Meadows, Chairman, and Ron Funk. Also present were Power County Clerk Christine Steinlicht and Power County Prosecuting Attorney F. Randall Kline.

ORDER FOR CANCELLATION OF TAXES: Moved by Commissioner Meadows, seconded by Commissioner Funk, to approve the Order for Cancellation of Taxes as presented by Power County Treasurer Bobbie Mauch. Carried.

<u>JUNIOR COLLEGE – CERTIFICATES OF RESIDENCY</u>: Moved by Commissioner Meadows, seconded by Commissioner Funk, to approve the Certificates of Residency submitted by the College of Southern Idaho. Carried.

SIXTH DISTRICT JUVENILE DETENTION FACILITY – EXPANSION (NOTICE OF PUBLIC HEARING): The Commissioners reviewed proposed Power County Resolution #2008-08, which is a resolution to file a petition for judicial review and examination under Idaho Code #7-1304, to proceed with financing of a law enforcement facility to be located in Bannock County, Idaho, consisting of a twenty-four (24) cell addition to the Sixth District Juvenile Detention Facility to be shared by all Counties in Idaho's Sixth Judicial District, which is estimated to cost up to approximately two million (\$2,000,000) dollars. Following discussion, it was moved by Commissioner Meadows, seconded by Commissioner Funk, to publish the Notice of Public Hearing on proposed Power County Resolution #2008-08 in the October 8<sup>th</sup> and 15<sup>th</sup>, 2008 editions of the Power County Press, with public hearing scheduled for Monday, October 27<sup>th</sup>, 2008, at 11:30 a.m. Carried.

<u>POWER COUNTY TREASURER – WARRANTY DEEDS</u>: Moved by Commissioner Meadows, seconded by Commissioner Funk, to approve and execute the following Warranty Deeds pursuant to public sale by the Power County Treasurer:

<u>POWER COUNTY SHERIFF – ENHANCED 911 UPGRADES</u>: Power County Sheriff Jim Jeffries appeared before the Commissioners to further review the proposed upgrades to Power County's Enhanced 911 system. Following discussion, Sheriff Jeffries agreed that he would like additional time to review options before proceeding further, and requested that this matter be removed from the agenda at this time.

<u>POWER COUNTY SHERIFF – JAIL MEDICAL PROVIDER</u>: Power County Sheriff Jim Jeffries appeared before the Commissioners to report that Correctional Health Care Management, Inc., will be submitting a proposed Contract to provide "in-house" medical services to the Power County Jail, which will need to be reviewed by Power County Prosecuting Attorney F. Randall Kline. Following discussion, the Commissioners agreed to table further discussion of this matter until October 14<sup>th</sup>, 2008.
