## **III. AGENDA**

### **A. NOTICES/REPORTS**

1. **Jail Inspection Report**: Commissioner Lasley advised he completed the quarterly jail inspection report. Discussion was had in executive session and no motions were made.

2. **5<sup>th</sup> District Meeting:** Commissioner Anderson advised that at the 5<sup>th</sup> district meeting was well-attended and productive meeting. Clerk, Sharee Sprague, advised that at the County officials Institute hosted in Lava, Seth Grigg and Sara Westbrook advised they want to host a meeting in American Falls. Commissioner Lasley advised that at the meeting they discussed a partnership district wide on autopsies/Pathology with Bannock County. Commissioner Anderson advised discussion was also had on a new law excluding the family members of morticians to be assigned as the Deputy Coroner.
